

RESOLUTION NO. R-16-174

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONER OF MANATEE COUNTY, FLORIDA, AMENDING RESOLUTION R-16-140 OF THE PARKS AND NATURAL RESOURCES FEE SCHEDULE; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, §125.01(1)(f), Florida Statutes, authorizes the Board of County Commissioners of Manatee County, Florida, as the legislative and governing body of Manatee County, to provide parks, preserves, playgrounds, recreation areas, and other recreation and cultural facilities and programs; and

WHEREAS, parks and natural resources services are funded in part by user fees generated to cover all or a portion of the costs of such services so as to minimize the burden on the County's general revenue;

WHEREAS, Manatee County's parks and preserves are open to the public and used for the operation of planned special events organized and supervised by the Parks & Natural Resources Department; and

WHEREAS, Manatee County Code §2-24-12 provides that the Board of County Commissioners may, upon recommendation of the Parks and Natural Resources Department Director, adopt, modify or rescind fees or fee ranges for access to various facilities or services offered by the County; and

WHEREAS, the County Commission has previously adopted various fees which have been made a part of the Parks and Natural Resources Master Fee Schedule, and

WHEREAS, the new changes now recommended for adoption are based upon changes to a definition, facility name change, and fees in the Master Fee Schedule.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, THAT:

1. The fee changes in Resolution R-16-174 are hereby amended, providing for the following changes to the Master Fee Schedule:
 - a. Add Drug-Free Youth Recreation Membership fee. (p.20)
 - b. Add 3-Month Recreation/Racquet Membership fee. (p.25)
 - c. Add 30-minute rental fee to use the Ball/Machine, with tennis balls. (p.26)
 - d. Add a rental fee for Racquet Center storage room. (p.26)
 - e. Lower Resale Item starting fee range from \$5 to \$1. (p.32)
 - f. Increase County Affiliated Little League Baseball/Softball, Soccer, and Football Leagues Athletic Field Light fees. (p.17)
 - g. Remove Daily Pass fee for pool only. (p.21)
 - h. Increase Youth Basketball Player fee. (p.29)
 - i. Remove Summer/Holiday Camp Bi-weekly and Half-day fees. (p.33)
 - j. Increase Youth Camps weekly Summer/Holiday Camp fee. (p.33)
 - k. Increase Recreation Membership fees. (p.20)
2. Fee changes a. – i. shall take effect as of January 3, 2017.
3. Fee changes k. and j. shall take effect as of April 1, 2017.

BE IT FURTHER RESOLVED that the provisions of this resolution are severable such that the invalidity of any one provision shall not operate to invalidate any other provision.
