Glass Chambers, 1112 Manatee Avenue West, Bradenton, Florida, to consider and act upon the following matters:

PDC-22-12(Z)(P)– Store Space Ellenton PSP Rezone/Storage Cap Ellenton JV LP/ (Owner) – PLN2204-0006

An Ordinance of the Board of County Commissioners of Manatee County, Florida, regarding land development, amending the Official Zoning Atlas (Ordinance 15-17, as amended, the Manatee County Land Development Code), relating to zoning within the unincorporated area; providing for a rezone of approximately 3.62 acres generally located approximately 300 feet north of US Highway 301 and 72nd Avenue East (Victory Road) and commonly known as 2704 72nd Avenue East, Ellenton (Manatee County) from Neighborhood Commercial-Medium (NC-M) to Planned Development Commercial (PD-C) zoning district; approving a Preliminary Site Plan for a mini-warehouse/self-storage facility, limited to a maximum 120,600 square feet; subject to stipulations as conditions of approval; setting forth findings; providing a legal description; providing for severability; and providing an effective date.

PDMU-22-14(P) – Ellenton Springhill Suites – Rocky Bluffs Lodging, LLC (Owner) – PLN2205-0120

An Ordinance of the Board of County Commissioners of Manatee County, Florida, regarding land development, approving a Preliminary Site Plan located on real property zoned PDMU/CHH (Planned Development Mixed Use/Coastal High Hazard) to allow development with a 119-room, 85,116.5 square foot 6-story (5-stories over parking) hotel with associated infrastructure and amenities, on 2.10 acres, generally located on the south side of 18th Street East, approximately 300 feet south of US 301 and 125 feet east of 60th Avenue East, and commonly known as 6115 18th Street East, Ellenton (Manatee County); subject to stipulations as conditions of approval; setting forth findings; providing a legal description; providing for severability; and providing an effective date.

PDMU-22-17(Z)(G) - East River Ranch/East River Ranch 1400, LLC (Owner) - PLN2205-0106

An Ordinance of the Board of County Commissioners of Manatee County, Florida, regarding land development, amending the Official Zoning Atlas (Ordinance 15-17, as amended, the Manatee County Land Development Code) relating to zoning within the unincorporated area; providing for a rezone of approximately 1,381.63 acres from A/WP-E/WP-M/ST (General Agriculture/Watershed Protection Evers /Watershed Protection Lake Manatee/Special Treatment Overlays) to the PDMU/WP-E/WP-M/ST (Planned Development Mixed Use) zoning district, retaining the Watershed Protection Evers/Watershed Protection Lake Manatee and Special Treatment Overlay Districts; generally located at the southwest corner of SR 64 East and CR 675, at 21100 SR 64 East, Bradenton (Manatee County); approving a General Development Plan (Large Project) for up to 5,378 residential units (single-family detached, single-family semi-detached, single-family attached and multi-family); 900,000 square feet of commercial/retail uses; 300,000 square feet of office uses; 300,000 square feet of mini-warehouse uses; a future potential charter school grades K-12; and a future potential fire station facility; subject to stipulations as conditions of approval; setting forth findings; providing a legal description; providing for severability; and providing an effective date.

PDR-22-13(Z)(G) - Heron Glen - Kenneth Davis (Owner) / KB Homes - PLN2205-0039

An Ordinance of the Board of County Commissioners of Manatee County, Florida, regarding land development, amending the Official Zoning Atlas (Ordinance 15-17, as amended, the Manatee County Land Development Code), relating to zoning within the unincorporated area; providing for a rezone of approximately 34 acres generally located approximately 1,400 feet west of Ellenton-Gillette Road on 85th Street E and commonly known as 3120 E 85th Street, Palmetto (Manatee County) from A-1 (Agricultural Suburban) to the PDR (Planned Development Residential) zoning district; approving a General Development Plan for 130 single-family detached residential units; subject to stipulations as conditions of approval; setting forth findings; providing a legal description; providing for severability, and providing an effective date.

ZL-23-01 – Sweetberries Rezone/Sweetberries III Inc (Owner) – PLN2210-0035

An Ordinance of the Board of County Commissioners of Manatee County, Florida, regarding land development, amending the Official Zoning Atlas (Ordinance 15-17, as amended, the Manatee County Land Development Code), relating to zoning within the unincorporated area; providing for a rezone of approximately 0.33 acres generally located 130± feet north of the intersection of Manatee Avenue West and 46th Street West on the east side of 46th Street West at 419 46th Street West, Bradenton (Manatee County) from RSF-4.5 (Residential Single Family District) to the GC/L (General Commercial/Limited) zoning district; approving a Schedule of Permitted and Prohibited Uses as voluntarily proffered by the Applicant and attached as Exhibit B; subject to stipulations as conditions of approval setting forth findings; providing a legal description; providing for severability, and providing an effective date.

Z-23-04 - Desrosiers Excavating Rezone – Desrosiers Excavating Inc (Owner) - PLN2211-0083

An Ordinance of the Board of County Commissioners of Manatee County, Florida, regarding land development, amending the Official Zoning Atlas (Ordinance 15-17, as amended, the Manatee County Land Development Code), relating to zoning within the unincorporated area; providing for a rezone of approximately 13 acres from A-1 (Agriculture Suburban) to the LM (Light Manufacturing) zoning district part of a 15 acres site (2 acres are zoned LM) and being generally located north of Tallevast Road on the east side of 28th Street Court East, commonly known as 7325 28th Street Court East, Sarasota (Manatee County); setting forth findings; providing a legal description; providing for severability, and providing an effective date.
