Program Presentation- Foundation for Dreams; Dream Oaks Camp

Elena Casella from Foundation for Dreams provided a presentation on the Dream Oaks Camp program and services that the program provides to the children and parents within Manatee County. Devonte Ousley, Camp Director, provided testimony from some of the children. Stuart Offner, a program participant's parent, detailed the services that his daughter receives at the camp and praised the program's staff for their empathy, kindness, and expertise.

Program Presentation- One to One Mentoring; Big Brothers Big Sisters Suncoast

Jeanie Biak from Big Brothers Big Sisters Suncoast's One to One Mentoring program provided history, program updates, shared information on the services the program provides to clients and families, recent results from FY22-23, and plans for the program for FY24. Ms. Biak provided a brief PowerPoint and fielded questions from CSAB members.

Carolyn McBean from AMIKids Prevention provided a history on the AMIKids program and shared an update on the status of the program. Debbie Tapp requested an update on the status of the Rubonia Community Center. Kristi Hagen shared that Kids Club had previously provided their Letter of Intent, but has since been unable to obtain the required Department Children and Families licensure. Mrs. Hagen has been in
