Melissa Bomar provided the following updates:

 Reviewed recent compliance visit conducted for Foundation for Dreams, Dream Oaks and there was nothing of concern noted during the observation.

New/Old Business

Melissa Bomar provided an update on the answers Palmetto Youth Center staff provided for the CSAB Members after the funding review meetings for the Foundation For Excellence Program (Batch 6 – April 5). Discussion ensued amongst the CSAB Members. Melissa fielded questions from CSAB members to clarify the answers provided. There are concerns about the submitted budgets for staff funding and the possibility of duplication of services for clients within this agency's programs that receive investment from Children's Services millage.

- Becky McDonough, ALSO for Gay Youth: Spoke of her appreciation to speak to the CSAB Members on the program. Provided background on her career and her position as the Executive Director. Spoke on the model currently in operation in the Sarasota location and that Manatee County clients are being served there.
- Mary Tavarozzi, ALSO for Gay Youth: Thanked the CSAB Members for their time to review. Spoke on the history of the program and agency and the importance of not turning youth away despite where they reside and the pride the agency has in serving the youth. Spoke on her excitement to be able to provide in-person services.
- Amy Wick Davis, PACE Center for Girls: Thanked the CSAB Members for their support and ongoing investment. Reviewed the recent changes made to the home location of the program and their fundraising to pay for the new buildings to serve more girls.
- Christi Haley, PACE Center for Girls: Spoke on the increase requested and the importance of the Transition Services Result and to expand the number of clients served.
- Danielle Visone, Tidewell Hospice: Thanked the CSAB Members for the recommendation for funding for current FY23. Clarified the program did receive an MOU with the School District of Manatee County.
- Nicole Murby, Easter Seals Southwest Florida: Spoke on the agency history in the area
 and the funding support needed to improve the lives of the clients they served. Provided
 a summary of the growth of the program due to the needs of the community. Addressed
 concerns for funding increase and clarified the increase of therapies provided to the
 children instead of increasing the number of clients served. Reviewed the criteria the
 program utilizes to identify the risk factors for clients.
