### Staff Updates

Susan Ford provided the following updates:

- We are pleased to introduce Johanna Beville, the newest Human Services Analyst, who started on January 4<sup>th</sup>.
- After years of having a vacancy in the judicial seat, we have now received an application for the Honorable Scott Brownell who is up for appointment by the BOCC on January 26<sup>th</sup>. He will be

- joining us at the February meeting. After much negotiating with the Chief Judge, we were granted permission to take applications from retired judges who are not active in the court.
- With much sadness, we are sharing the passing of Mary Smith, the Executive Director of Family Network on Disabilities who was a hero for the disabled children and their families in this community. Mary battled many bouts with cancer and was no longer able to fight when it spread throughout her body. Mary leaves behind a dedicated husband and three adult children, two of which had special needs. She will be greatly missed in our community.

Debbie Tapp reminded the board that an updated CSAB Meeting Schedule 2021 was provided in the meeting materials. Future meetings will be held in the Manatee/Osprey Room, County Admin-5<sup>th</sup> floor.
