- Observed Early Learning Coalition's Subsidy and Match Program for a compliance review visit, nothing of concern noted during the observation.
- Observed From Cradle to College's Operation WIT Program for a compliance review visit, there is ongoing concern the program is being provided 1:1 when the program is designed to be delivered as a cohort.

## New/Old Business

Debbie Tapp thanked members for submitting their initial scores in a timely manner.

Charlie Kennedy shared the SOAR in 4 event is occurring this evening at Bishop Planetarium at 5:30pm.

Connie Shingledecker shared Manatee County for Safe Kids is partnering with Sarasota County to host an event on April 15, 2022 from 12pm to 3pm at University Town Center Mall.

Xtavia Bailey shared the Angel Watches is presenting their inaugural fundraising event for gap funding on May 18, 2022 at the Manatee Performing Arts Center from 11:30 am to 1pm.

## Public Comment

Agencies who verbally provided a public comment during the meeting were:

(In Person): Patrick Ryan, Nicole Murby, Deirdre Guilloton, Tari Allen, Ebony King; (Virtually): Bill Greener, and Shpresa Kaletsch.

- Patrick Ryan, *Easter Seals of Southwest Florida*: Clarified concerns members raised during review for the gross revenue of Easter Seals from 2 years ago and 1 year ago being due to the acquisition of In Stride Therapeutic Riding Center and adding their assets to Easter Seals, as well as there being an increase in state funding.
- Nicole Murby, *Easter Seals of Southwest Florida*: Addressed the funding application for the program as they are asking for an increase in funds, what it will provide for children including 130 hours of therapy, the different types of therapy services, 70 children on the waitlist and the need for those children who are under insured or not insured. Thanked the members for their work.
- Deirdre Guilloton, *Centerstone of Florida CAT Team*: Spoke on the increase in chronic symptoms of clients being admitted and it is increasing the length of treatment time. Also, spoke on how the increase in funding would improve services.
- Tari Allen, *Centerstone of Florida Sexual Assault and Advocacy*: Thanked the members for all they do. Also, spoke on the services provided by the program, on advocacy services provided and that it doesn't meet the criteria for results. Spoke on the number of clients served for the therapy program and reasoning for the lower client consensus for the last 2 years.
- Ebony King, *Centerstone of Florida*: Thanked the members for all they do and allowing the programs to provide services to the community members. Addressed the incident a member was concerned about and shared there is a 6 youth to 1 staff member with 15-minute checks for clients on the children's crisis unit. Also spoke on how the agency responds if an incident arises. Spoke on the program being critical care within the 72-hour window and the step-down appointments services provided.
- Bill Grenier, *Meals on Wheels Plus*: Thanked the members for their consideration of the grant application. Spoke on the dental benefits which caused confusion during review as it was an error when completing the application.
- Shpresa Kaletsch, *Centerstone of Florida*: Addressed the concerns voiced by members during program review and spoke on Mental Health Evaluation program having safety being the number 1 priority. Reviewed the building houses numerous programs with different types of staff which allows programs the flexibility to adjust ratios as needed.
