#### **Shared Results Presentation**

Robyn Faucy-Washington, Results First (CEO) and Jody Jester, Bridge a Life (Director of Programs) shared a PowerPoint presentation on the details of shared investing for foster care organizations in Manatee County. The foster care initiative is 3-way partnership between Manatee County Government, United Way of the Suncoast, and Manatee Community Foundation. Robyn reviewed the program targets, participants, approach, common framework, and the results. A follow up document will be provided with the complete summary results.

# Manatee County Local Licensing Presentation

Paul Sharff, Early Learning Coalition (CEO) provided a presentation and proposal for local Manatee County childcare licensing. His intent is to set up a new and separate not-for-profit that will accomplish this. He is requesting consideration from the CSAB to provide \$250,000 from Manatee County Government's Children's Services Millage reserve funds. Paul reviewed the benefits of and reasons for this proposal and reviewed the proposed budget. An open discussion ensued. Paul fielded questions posed to him by the CSAB Members. Chantal Porte, FL Dept of Children/Families – Child Care Regulation, spoke on her role and responsibilities and how she and her staff work with the Manatee County providers regarding state standards and statutes in place to maintain safety, including the process a childcare provider goes through to obtain and maintain DCF (Department of Child and

Families) Licensure. Chantel also provided a review of the onsite visits that are conducted, noting that providers are not made aware of when DCF is coming for an inspection, and that there is not a minimum requirement for DCF to go out to each location per year. If there are complaints, follow-up visits are conducted, and locations are visited 2 times.

**Motion:** The CSAB recommends to the Board Of County Commissioners the initiation of the process to explore the creation of a Manatee County Child Care Licensing Board, pending an opinion from the County Attorney's Office that Manatee County Children's Services Ordinance (Manatee County Code of Ordinances Chapter 2.2 Administration, Article IX, Sec. 2-2-255 – Expenditures Authorized), authorizes funding from the Children's Services millage is allowable spending for such a project, **Action:** To Approve, **Moved by** Charlie Kennedy, **Seconded by** Carolann Garafola, **Vote:** Motion passed (Summary: Yes = 10, No = 0, Abstain = 1). **Conflicts:** Kim Kutch is abstaining due to a conflict with Department of Children and Families. **Public Comment:** None.
