■ Dental Services:

- Basic dental care, including cleanings, fillings, extractions, partial dentures, but not root canals and crowns
- Manatee County residents, ages 5-70, income at or below 200% of Florida poverty level
- 4530 services provided in 2014/15
- \$9 million worth of dental services provided 2009 – 2015

■ Staff:

- Volunteer physicians, dentists, pharmacists, nurses, dental hygienists who are currently in practice or retired and licensed in Florida
- Lake Erie College of Osteopathic Medicine (LECOM) 4th year medical students and a physician preceptor see patients in morning clinics
- Liability insurance is provided through the State of Florida to clinics providing free health and dental services to underserved populations
