Centerstone of Florida	Baker Act (Adult)	\$709,745.00	\$0.00	This program will provide Baker Act Services pursuant to Florida Statute Chapter 394, Part I to Manatee County Residents eighteen years of age and over, in acute psychiatric distress who have been determined to be a threat to themselves or others as a result of their mental illness or are in need of inpatient psychiatric stabilization. Services will include general medical, psychiatric evaluation, medication, safety monitoring and individual, group and family counseling. This program runs 24 hours per day, 7 days per week.
	Rape Crisis(Adult)	\$52,343.00	\$0.00	This program will provide Rape Crisis Services to Manatee County Residents who are victims of sexual assault or to victims of sexual assault which occurred in Manatee County and their families or significant others. Services include outreach services, crisis intervention counseling, follow-up contact, criminal support/advocacy, information and referral, assistance with crimes compensation claims and home visits, assistance with medical services and support groups 24 hours per day/7 days per week.

	Inpatient and Residential Detox.	\$811,100.00	\$0.00	<p>This program will provide inpatient substance abuse detoxification services to Manatee County Residents, eighteen years of age and over. Services will include patient screening and observation, medically supervised drug and alcohol detoxification, nursing, physician and other clinical services, physical evaluation, medication management and administration, therapeutic counseling, coaching and support and educational programs 24 hours per day/7 days per week.</p>
	Marchman	\$450,000.00	\$0.00	<p>This program will provide Addictions Emergency Response Services (Marchman Act) pursuant to Florida Statute, Chapter 397, The Hal S. Marchman Alcohol and Other Drug Services Act to Manatee County Residents age 18 and over, who meet Agency criteria for assessment and treatment under the Marchman Act. Services will include in-depth patient assessment, access to center nurses, counselors, therapists and physicians as needed, conduct interview with families to determine needs.</p>

Centerstone of Florida	Mental Health Transport	\$93,970.00	\$0.00	<p>This program will provide safe and comfortable Mental Health Transport Services within Manatee County from the Manatee Memorial Hospital Emergency Department to the Centerstone of Florida Hospital and Crisis Center to individuals who have been medically cleared after receiving emergency medical care at the Manatee Memorial Hospital Emergency Department, who do not require stretcher transport, and require transport to the Centerstone of Florida Hospital and Crisis Center for evaluation and stabilization under the Baker Act and transport to out-of-county locations as mandated by Florida Statute. Services will include On-demand transport within 2 hours, transportation coordination, drivers with good driving records and training in dealing with persons in acute psychiatric distress.</p>
	Rape Crisis Child Advocacy and Therapy/K.I.T.E.	\$0.00	\$99,747.00	<p>Provides on call crisis counseling, education and support, intervention, treatment, and empowerment services to children ages 0-17 who are victims of sexual abuse and their families.</p> <p>ADVOCACY: Through a 24-hour crisis call line, Agency shall provide Client with access to a victim advocate who shall arrange needed legal, medical, and behavioral health services throughout the recovery process. Program shall provide, but is not limited to, accompaniment to all law enforcement interviews including line-ups, photo pack review sessions, and controlled phone calls; accompaniment to all court related interviews including pre-filing interviews, depositions, hearings, and trials; and assistance in filing compensation claims and information referrals.</p> <p>THERAPY.: Program services shall consist of an assessment to determine individual treatment needs and appropriateness of services, individual, family, and group (one or more members of two or more separate families) counseling designed to assist the Client in getting through the emotional crisis of sexual abuse and assault.</p>

Each level of treatment shall provide individual, family, and group therapy which will account for the base of each treatment plan, along with regular UDS (urine drug screens), a support network, psycho-educational services, crisis intervention, transportation, parenting skills, vocational services, tutoring and other educational services, 12-step recovery, psychopharmacology, in-home/onsite services, and a discharge plan that includes coordination of care and indicates if Client completed Program, completed required sessions, met goals and had clean UDS (urine drug screen) within the last 30 days prior to discharge, and was transitioned into or offered Aftercare.</p>

Services will include client eligibility screening, coordination of care between clients and participating entities, acting as liaison among Physicians, the Manatee County Medical Society, Primary Care Providers, Pharmaceutical Providers and Hospitals.
