TO REACH FROM THE INTERSECTION OF FL-43/US-301 NORTH AND FL-62/WAUCHULA ROAD, GO EAST ON FL-62/WAUCHULA ROAD FOR 19.0 MI (30.6 KM) TO THE INTERSECTION WITH KEENTOWN ROAD ON THE RIGHT AND CARLTON ROAD ON THE LEFT. TURN LEFT AND GO NORTH ON CARLTON ROAD FOR 1.7 MI (2.7 KM) TO THE MARK ON THE RIGHT.

THE MARK IS 2 SECTIONS OF 3/4 INCH (2 CM) ALUMINUM ROD DRIVEN TO REFUSAL AT A DEPTH OF 5.8 FT (1.8 M) ENCASED IN A PVC SLEEVE PACKED WITH SAND AND SURROUNDED BY CONCRETE, CAPPED WITH A MANATEE COUNTY LOGO CAP WITH AN EMBEDDED MAGNET FLUSH WITH THE GROUND.


