AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, PROVIDING THAT THE MANATEE COUNTY CODE OF ORDINANCES BE AMENDED BY REVISING CHAPTER 2-4; TO ESTABLISH LIMITS AND REGULATIONS RELATED TO THE SALE OF ANIMALS; PROVIDING FOR OTHER MODIFICATOINS FOR CLARITY AND CONSISTENCY; PROVIDING FOR ENFORCEMENT; PROVIDING PENALTIES FOR VIOLATIONS; PROVIDING FOR AREAS EMBRACED; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

Consistent with the posting requirement set forth in Section 125.66(3)(a), Florida Statutes, the County hereby publishes the following BIE information for this proposed ordinance on its website for public viewing and consideration on this <u>3rd</u> day of <u>June</u> 2025:

1. Summary of Proposed Ordinance, Including a Statement of the Public Purpose to be Served by the Proposed Ordinance, Such as Serving the Public Health, Safety, Morals, and Welfare of the County:

The Manatee County Board of County Commissioners has adopted an ordinance amending Chapter 2-4 of the County Code to establish stronger regulations on the sale of animals. The ordinance is intended to protect animal welfare, public health, and community interests by addressing concerns about unsanitary and inhumane breeding practices. It includes new limits on retail pet sales, prohibits the opening of new pet stores, and introduces regulations for existing ones. The ordinance also aligns with federal standards but establishes stricter local rules, including enforcement provisions and penalties for violations. These updates build upon the previously adopted Ordinance 24-92, and expand oversight to improve consistency, accountability, and humane treatment of animals within Manatee County.

- 2. Estimate of Direct Economic Impact of Proposed Ordinance on Private, For-Profit Businesses in the County, Including the Following (if any):
 - a. An estimate of direct compliance costs that businesses may reasonably incur if the ordinance is enacted:

There are no direct compliance costs anticipated for businesses as a result of this ordinance. The ordinance does not require any additional reporting,

equipment, staffing, or procedural changes that would impose a financial burden on affected businesses.

a. Any new charge or fee on businesses subject to the proposed ordinance or for which businesses will be financially responsible:

There are no new charges or fees associated with this ordinance that would impact current businesses. All existing fee structures remain unchanged, and no additional financial obligations will be imposed as a result of the ordinance.

b. An estimate of the County's regulatory costs, including an estimate of revenues from any new charges or fees that will be imposed on businesses to cover such costs:

Direct compliance costs to businesses are expected to be minimal. Businesses may need to engage in limited communication with the Manatee County Development Services Department regarding permits and conduct basic internet research to ensure ongoing compliance. These activities are estimated to require approximately one hour per month of a Field Supervisor's time, resulting in minimal labor costs. No significant expenditures on equipment, materials, or outside professional services are anticipated.

3. A Good Faith Estimate of the Number of Businesses Likely to be Impacted by the Ordinance:

At this time, it is unknown if any pet stores that sell dogs or cats are seeking to locate in Manatee County. Existing pet supply companies, which do not sell dogs or cats, are not regulated under this ordinance and therefore are not expected to be impacted.
