DISCUSSION OF RECOMMENDATION PROCESS

Kristi Hagen, Children's Services Coordinator, reviewed 35 programs seeking an increase in investment for FY25, and encouraged Children Services Advisory Board (CSAB) Members to utilize the Decision-Making Guide - Request for Increased Investment and Tier Process, for Requested Increases to assist in making a final determination if a program qualifies for consideration for a recommendation of increased investment. Ms. Hagen also provided clarity on the role of staff in drafting agreements with agencies by utilizing the application and detailed conversation. Staff strive to understand the program and processes that are used to demonstrate service are provided and gains are achieved. Staff's goal is to ensure the details are accurate and complete based on what is learned and in the best interest of the community on behalf of Manatee County Government and Children's Services

Millage. Motions for recommendations may not include the utilization of staff to work with the agency to make the program services or Result better. (Enter Member Bailey)

Discussion ensued regarding the review process, scoring, and funding recommendation possibilities.

Ms. Hagen shared score ranges for investment applications for FY25 are as follows with one application scoring below 40, the rest are 55 or higher:

- Highest 92.90
- Lowest 38.90
- Average 79.94

CSAB INCREASE CONSIDERATIONS

Chairman Shingledecker facilitated the CSAB members' review and discussion regarding programs seeking an increase in investment for FY25 to determine if they are eligible to be recommended for increase in investment with final determinations below:

- Big Brothers Big Sisters of the Sun Coast One to One Mentoring Program:
 - o Program is requesting a 50 percent increase. CSAB Members consensus determined the program is eligible a tier two investment increase up to a maximum of \$21,000.
- Boys and Girls Clubs of Manatee County Great Futures Start Here (Ages 5-12 years old):
 - Program is requesting a ten percent increase. CSAB Members consensus determined the program is eligible for a tier two investment increase up to a maximum of \$92,500.
- Boys and Girls Clubs of Manatee County The Club Teen Program (Ages 13-17 years old):
 - Program is requesting a ten percent increase. CSAB Members consensus determined the program is eligible for a tier two investment increase up to a maximum of \$22,500.

 - o Program is requesting a 16 percent increase. CSAB Members consensus determined the program is eligible for a tier two investment increase up to a maximum of \$58,811.

 - o Program is requesting a seven percent funding increase and CSAB Members consensus determined it is eligible to be recommended for an increase for a tier one investment increase up to a maximum of \$23,800 investment for FY25 by member consensus.

 - Program is requesting a 90 percent increase. CSAB Members consensus determined the program may be eligible for a tier two investment increase up to a maximum of \$28,612.

 - Program is requesting a seven percent increase. CSAB Members consensus determined the program is eligible for a tier one investment increase up to a maximum of \$63,000.
- Step Up Suncoast Healthy Families Manatee:
 - Program is requesting a four percent increase. CSAB Members consensus determined the program is eligible for a tier one investment increase up to a maximum of \$17,358.
- Step Up Suncoast Home Instruction for Parents of Preschool Youngsters (HIPPY):
 - o Program is requesting a five percent increase. CSAB Members consensus determined the program is eligible to be recommended for an increase for a tier one investment increase up to a maximum of \$9,933 investment for FY25 by member consensus.
- Step Up Suncoast Parents as Teachers (PAT):
 - Program is requesting a four percent funding increase and CSAB Members consensus determined it is eligible a tier one investment increase up to a maximum of \$5,956.

 - o Program is requesting a four percent increase. CSAB Members consensus determined the program is eligible for a tier one investment increase up to a maximum of \$5,448.
- The Florida Center Early Childhood Court:
 - o Program is requesting a 15 percent increase. CSAB Members consensus determined the program is eligible for a tier two investment increase up to a maximum of \$49,713.
- The Salvation Army Housing Focused Shelter for Families:
 - o Program is requesting a seven percent increase. CSAB Members consensus determined the program is eligible for a tier one investment increase up to a maximum of \$7,000.
