# **Drowning Prevention:**

- In the 10-year span between 2013-2023, there were 36 deaths related to unsafe sleep.
- Reviewed data regarding Manatee County deaths by drowning.
  - Handouts per provided digitally with the meeting notice and physically at the meeting.
  - Department of Children and Families is working on a 5-year plan to address the pediatric drownings.
  - Need to determine what the distraction is where children are not supervised prior to the incident
  - Subcommittee conversation on how to have no pediatric drowning deaths in Manatee County
  - Pool barriers (operational, instructions)
  - Discussed Temporary Public Lodging Establishments (TPLEs) and safety standards (FL Statute 633.206)
     Unsure this would fit under the Ordinance
  - Florida pool/swim legislation
    - Swim vouchers (4 and younger)
  - Discussion on education, code enforcement/inspections
  - Near drowning data
  - Next steps for CSAB:
    - Awareness, prevention, education
    - Swim lessons and water safety
    - Life jacket kiosks (partner with other entities throughout Manatee such as public safety and libraries)
    - What to include for TPLE owners
      - What to include regarding water safety
      - Liability and mitigation data
- Connie is working towards getting data for youth deaths by suicide. Suicide teen deaths are on the rise. Mental health and social media driven deaths.
