Call to Order/Welcome

Connie Shingledecker, Co-Chair called the meeting to order at 3:07 p.m.

Staff Updates

Chris Handy Honeycutt provided the following updates:

- Boys and Girls Club, Sandra Vega Piketty has left the program and has been replaced by Kim Moultrie. Program is working with staff for Results for the FY 21/22 Teen Program agreement to bring them more in line with other mentoring programs focusing on general social growth rather than just employability skills.
- Family Network on Disability Parent Mentoring and Support Classes are being provided virtually due to COVID. County staff reports that virtual classes are as effective as in-person classes. Program is working to build a strong support network amongst their clients. Clients are utilizing each other as a support and working collaboratively.

Johanna Beville provided the following updates:

- The Early Learning Coalition – Sharon Oakes has left the agency and Darrell King is the new Chief Operations Officer.
- Replay Outreach had a change in Program Directors. Vernon Kearney has resigned, and Tim Frost has taken the position. Tim has experience working as a director of a program that served At-Risk Teens and is also a former teacher from Pinellas County. Replay is working to coordinate with the Manatee County School Board to offer the program in some middle and high schools.
- Step Up Suncoast's Board of Directors selected Amy Tittle (long standing Chief Operations Officer) as the agency's next President and Chief Executive Officer. Amy replaced retiring President and Chief Executive Officer Barbara Patten on September 1, 2021.
- Family Resources has hired Breanna Knuth as Director of Client Success for Manatee. She will be providing clinical support and oversight for the CERTAIN, SafePlace2B, and community counseling programs.
