

The Children's Services Advisory Board (CSAB) holds a day-long annual retreat dedicated to identifying and discussing issues affecting children and families in Manatee County. This annual session gives CSAB members the focused time they need to:

- Review current issues and emerging concerns impacting children and families
- Examine community data, trends, and outcomes related to children's services
- Assess successes, gaps, and areas needing improvement across local programs
- Collaboratively refine Board priorities, targets, and strategic direction
- Strengthen their shared understanding of community needs to guide future funding recommendations

The retreat helps the Board maintain a clear and collaborative approach to supporting Manatee County's children—ensuring that the community's investments reflect real needs and promote positive outcomes.

State of the Community

Children and families in Manatee County continue to make progress in education, health, and early development. Yet, many still face persistent challenges in accessing affordable childcare, behavioral health care, food, housing, and other essential supports. A coordinated, prevention-focused approach remains critical to ensuring every child can thrive.

Child & Family Well-Being

County partners are aligning priorities around prevention, literacy, health, and stability. Developing a cross-sector child well-being dashboard would enable data-driven coordination and equitable resource distribution across neighborhoods. Manatee County partners with Unite Us and will move not-for-profits that receive investment through the millage to that dashboard.

Child Removal Rates & Foster Care

According to the Florida Department of Children and Families, Manatee County continues to experience child removal rates above the state average. Between July 1, 2022, and June 30, 2025, the county recorded 635 removals to out of home care, including foster care, relative placements, and non-relative placements—a rate of 5.3 per 100 children compared to the statewide rate of 3.7. The leading causes of removal were caregiver drug or alcohol misuse and inadequate supervision. Despite elevated removal rates, Manatee County's timeliness to permanency consistently exceeds state performance. During the same period, 36.84% of children achieved permanency within 12 months, surpassing the statewide rate of 30.20%. While this reflects meaningful progress, the data underscores a continued and urgent need for upstream prevention efforts and family-stabilization services to reduce removals and strengthen long-term child and family well-being.

Children with Special Needs

While early intervention services do exist, many families experience delays due to limited staffing, long waitlists, and slow referral processes. Strengthening the system through timely developmental screening, coordinated family navigation, expanded therapy opportunities, and smooth transitions into school services would greatly enhance developmental outcomes for children with special needs.

Early Care & Kindergarten Readiness

In Fall 2024, 1,454 of 3,591 (40%) Manatee County FAST (Florida Assessment of Student Thinking) takers achieved "Kindergarten Readiness" (FLDOE). Limited infant/toddler care, staff shortages, and affordability barriers persist. Expanding high-quality early learning and family engagement programs is essential to improve readiness and long-term achievement.

Food & Shelter

According to Feeding Tampa Bay, child food insecurity affects roughly 1 in 4 children in Manatee County, and many families face rising rent burdens. Food and housing instability undermine children's health and school performance. Strengthening meal programs, mobile food access, and housing supports is key to family stability.

Physical & Mental Health

Based on the result of the Florida Youth Substance Abuse Survey (FYSAS), a substantial proportion of youth report symptoms of depression (feelings of worthlessness, failure and sadness). Behavioral health needs among children and youth are increasing. With provider shortages and long wait times, expanding services to include in-school and in-home mental health programs, enhance mental health screening, and access to telehealth will help close this critical gap.

Safety: Preventable Child Deaths Due to Drowning & Unsafe Sleep

The Manatee County Child Death Review Team recognizes drowning and unsafe sleep practices as leading causes of preventable causes of death among Florida children under five. Manatee County averages 3 child drownings per year, now ranking 16th among Florida counties. Manatee County averages 5 infant deaths annually (2020-2024) that are linked to unsafe sleep environments. In both situations, sustained education for the community and service providers, along with essential equipment-distribution programs, are vital to prevention.

Stabilizing Families & Parent Education

Rising living costs, food insecurity, and transportation barriers strain families. Evidence-based home visiting, coordinated economic supports, parenting education, and access to community resources help prevent child maltreatment and strengthen family resilience.

Youth Development & Literacy

Access to quality after-school and enrichment programs varies by neighborhood. Roughly half of third graders read on grade level, underscoring the need for early literacy interventions, mentoring, and career-readiness programs to promote lifelong success. Based on data from the 2024-25 school year, 35% of 3rd graders who attended VPK somewhere in the state, were 60% more likely to be on grade level for 3rd grade reading. Showing the demonstrating the connection of quality early education and youth literacy.

Priorities and Targets

A.

Children are safe in their homes, free from abuse or neglect.

A1. Children remain in their homes free from abuse and neglect, avoiding the need to re-enter foster care


A2. Children who enter foster care gain a permanent, stable, and nurturing home within 12 months and remain there.

B.

Children develop literacy skills necessary to be successful in school.

B1. Children who demonstrate below developmentally appropriate or grade level literacy skills, reduce their existing gap towards developmentally appropriate or age-appropriate literacy skills.

B2. Children who attain grade level or developmentally appropriate literacy skills will maintain grade level or developmentally appropriate literacy skills.



C.


Children have the skills necessary to function appropriately in all environments.

C1. Children with symptoms of adverse indicators of behavioral health as identified objectively by a measure of level of functioning determined by the program will build protective factors.

C2. Children who use drugs, alcohol, or other substances, or are at risk of use, will stop or resist use, and establish a plan to manage triggers.

C3. Children with one or more incidents of referral or suspension for aggression, bullying, harassment, or other negative action aimed towards another group or individual, will reduce those incidents.

C4. Children will learn and demonstrate appropriate social, emotional, and impulse control and regulation skills in relevant environments as identified objectively by a measure of level of functioning as determined by the program.



D.

Parents and caregivers have the skills and resources needed to stop preventable child death.

D1. Children will be safely placed to sleep in accordance with the Sleep Baby Safely initiative of Manatee County.

D2. Children and families will implement water safety practices at home and in all environments where water safety is a concern.







Manatee County's Drowning Prevention Initiative



The Manatee County Drowning Prevention Initiative represents a collaborative, community-driven effort focused on decreasing preventable drowning incidents through comprehensive education, public awareness, and increased accessibility to water safety resources. The initiative underscores the critical role of attentive supervision, swimming competency, the use of appropriate safety equipment near water, and preparedness for emergency response. Its primary objective is to foster a strong culture of water safety that safeguards lives and enhances the overall well-being of individuals and families throughout Manatee County.

POOL SAFETY

NEVER LET YOUR CHILD HAVE ACCESS TO A POOL ALONE

Constant Supervision

Nothing is better than watching your child. If child is missing, check pool first.

Water Watcher

Designate someone as a "Water Watcher" when swimming. Take 15 minute shifts.

Fences

Enclose the pool with fence at least 4 feet in height with self latching and self closing gates.



Remove Temptation

Remove all pool toys when not in use.

Alarms & Locks

Install high locks and alarms on ALL door and windows leading to the pool. Remove all pet doors. Add pool surface alarms to pool or personal immersion alarm for child.





Program Investments by Priority

Manatee County Government utilizes available funds from the Children's Services Dedicated Millage to ensure a lasting positive impact on the lives of Manatee County's youth. These youth have experienced abuse or neglect, have adverse childhood experiences or risk factors, or come from economically disadvantaged backgrounds. These funds provide financial assistance, through investment, to local non-profit organizations dedicated to helping children and their families achieve necessary improvements and mitigate risk factors.



\$20,495,073 was approved with a total of 63 programs receiving investment through the Children's Services Millage.






