#### **Background Discussion**

Manatee County is an entitlement community through the U.S. Department of Housing and Urban Development (HUD) for the Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), and Emergency Solutions Grant (ESG) programs.

HUD approved Manatee County's 2023-2028 Consolidated Plan in October 2023. The programming goals identified by Manatee County for the five-year entitlement funding

cycle include: Goal 1 - Increase access to affordable housing; Goal 2 - Reduce homelessness in Manatee County; Goal 3 - Support health care and wellbeing activities for special needs populations; Goal 4 - Provide access to community supportive services and economic development opportunities; and Goal 5 - Expand Community Development Strategies.

In preparation for the FY 2025/26 HUD-funding cycle, a grant application workshop was held on March 3, 2025, with interested organizations. Applications for funding were due on April 4, 2025.

In April 2025, staff conducted a review of the completeness of all grant applications received by the deadline to ensure they met the threshold requirements outlined in the application. An Application Review Committee of eight county staff as well as one member of the Suncoast Partnership to End Homelessness, Inc (Continuum of Care Lead Agency) and one member of the Manatee County Housing Authority were convened to review each application based upon the priority needs, goals, strategies identified in the five-year Consolidated Plan, and the needs and gaps. In addition, they reviewed the applications for collaboration/partnerships, leveraging of other funds, performance measures, and outcomes among other criteria.

Manatee County anticipates that its funding allocation from HUD for FY 2025/26 will be as follows: CDBG will be \$1,833,537.00, HOME will be \$588,051.16, and ESG will be \$157,808.00. County staff has also identified an additional \$37,814.00 in Prior Year CDBG funds, \$121,836.00 in Prior Year HOME funds, \$39,000.00 in CDBG Program Income funds, and \$106,230.00 in HOME Program Income funds available from repayments and balances from completed projects.

In addition to the regular entitlement funding, applications were also open to allocate the special Community Development funding under the HOME-American Rescue Plan (HOME-ARP), ESG-Rapid Unsheltered Survivor Housing (ESG-RUSH), and CDBG-CARES Act (CDBG-CV).

Based upon priority needs and available funding, the Review Committee recommends funding nine CDBG-eligible activities, three HOME-eligible activities, one ESG-eligible

activity, four HOME-ARP-eligible activities, two ESG-RUSH-eligible activities, and two CDBG-CV-eligible activities.

The 2025/26 Application Recommendation Summary of proposed projects and activities is presented for the Board's consideration and approval on June 3, 2025, for inclusion into the FY 2025/26 Annual Action Plan. Following approval of the proposed projects and activities, the draft 2025/26 HUD Annual Action Plan will be finalized, and the 30-day public comment period, commencing on July 1st, 2025, will be advertised.

The FY 2025/26 Annual Action Plan will be scheduled for a public hearing and approval at the BCC July 30th meeting. We will submit the FY 2025/26 Annual Action Plan to HUD no later than August 16, 2025, as required by HUD.

HOME-ARP funds are presently available for the commitment and implementation of activities. If the Board of County Commissioners concurs with the Review Committee's recommendations for the HOME-ARP application approvals, Resolution R-25-105 is available for final adoption.

For the ESG-RUSH and CDBG-CV funds, Resolutions with the final decisions made by the Board of County Commissioners will be presented at the upcoming Board meeting on June 17th, 2025.

Subject: FY 2025/26 CDBG/HOME/ESG, HOME-ARP, ESG-RUSH & CDBG-CV Recommendation for Funding – Review Committee

The Review Committee for the FY 2025/2026 CDBG / HOME / ESG / HOME-ARP / CDBG-CV / ESG-RUSH Funding Applications convened on May 7<sup>th</sup> to define the final funding recommendations to the Board of County Commissioners.

The Review Committee was formed by the following individuals:

Each reviewer scored the individual applications using the Neighborly application system. The main determinants for funding recommendations included alignment with grant rules and objectives, available funding, Consolidated Plan Priority Needs, average scoring on project objectives and narrative descriptions, project readiness and feasibility, supporting documentation, past performance, and current open contracts/funding.

Based on these components, the Review Committee recommends funding nine CDBG-eligible activities, three HOME-eligible activities, one ESG-eligible activity, four HOME-ARP-eligible activities, two ESG-RUSH-eligible activities, and two CDBG-CV-eligible activities.

A total of 17 applications are not being recommended for funding due to factors such as ineligibility, incompatibility with grant rules, insufficient funding, or the need for further/revised information for future application cycles.

In addition to the recommended projects, staff followed the set-asides allowed by HUD for Administration and Planning for the regular CDBG, HOME, and ESG annual entitlements, as well as the recently awarded ESG-RUSH special allocation.

**WHEREAS**, these special HOME-ARP funds are to be used to provide homelessness assistance and supportive services; and

**WHEREAS**, on July 27, 2021, the Board of County Commissioners approved Resolution R-21-117, adopting the FY 2021-2022 HUD Annual Action Plan; and

**WHEREAS**, on February 28, 2023, the Board of County Commissioners approved Resolution R-23-038, adopting the HOME-ARP Allocation Plan as part of a substantial amendment to the FY 2021-2022 HUD Annual Action Plan; and

**WHEREAS**, on November 14, 2023, the Board of County Commissioners approved Resolution R-23-202, adopting the Amendment to the HOME-ARP Allocation Plan to carry out activities not previously identified in the original HOME-ARP Allocation Plan; and

WHEREAS, on July 30, 2024, the Board of County Commissioners approved Resolution R-24-145, committing specific HOME-ARP funded activities to carry out the objectives of the HOME-ARP Allocation Plan; and

**WHEREAS**, approval of the present Resolution is required to commit available HOME-ARP funds to eligible activities.

## NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, THAT:

- 3. The Director of the Community and Veterans Services Department, or designee, is hereby authorized to approve and execute subrecipient funding agreements,

amendments, associated standard Land Use Restriction Agreements, environmental reviews and assessments, policies and procedures governing the implementation of the HUD entitlement programs and authorize payments up to the maximum allowable funding for Manatee County's HUD entitlement funding under HOME-ARP program activities as approved and adopted by the Board of County Commissioners in Manatee County Consolidated Plan and Annual Action Plans.

- 4. The Director of the Community and Veterans Services Department, or designee, is hereby authorized to approve and execute changes in project and activity scope, funding, and location, project and activity creation, elimination, and funding reallocations associated with the Manatee County Consolidated Plan and Annual Action Plans, following decisions made by the Board of County Commissioners, requirements of the Citizen Participation Plan and all applicable Federal Regulations governing Manatee County HUD Entitlement Funding.
- 5. Submission of this resolution to the U.S. Department of Housing and Urban Development is hereby authorized.
