

RESOLUTION R-20-086

**A RESOLUTION ADOPTING THE MANATEE COUNTY
LOCAL MITIGATION STRATEGY PLAN (LMS)**

WHEREAS, Manatee County is located in an area that is vulnerable to natural and man-made disaster;

WHEREAS, Manatee County supports efforts to make our community more disaster-resistant, thereby reducing the costs of disaster, preventing or mitigating their impact to our residents and reducing time needed for recovery;

WHEREAS, the Local Mitigation Strategy represents a unified county-wide strategy toward a more disaster-resistant community;

WHEREAS, the Local Mitigation Strategy is scheduled for adoption every five (5) years hereafter, per stipulations set forth in the Disaster Mitigation Act of 2000, Public Law 106-390 (aka DMA2K) by the Federal Emergency Management Agency (FEMA); and

WHEREAS, the Local Mitigation Strategy provides the consistent framework for future pre-disaster mitigation efforts and post-disaster redevelopment, regardless of the type of future threat faced by our community.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA AS FOLLOWS:

SECTION 1. APPROVAL OF THE 2019 LOCAL MITIGATION STRATEGY PLAN.

The Board hereby approves the 2019 Manatee County Local Mitigation Strategy developed by the LMS Working Group:

Background Discussion

The Local Mitigation Strategy Plan (LMS) is the representation of a jurisdictions commitment to identifying, evaluating and planning to reduce risks from natural and man-made hazards. This multi-jurisdictional plan analyzes a wide range of community plans, capabilities, stakeholders and community characteristics to develop effective mitigation initiatives for the community, while also serving as a guide for decision makers as they commit resources to reducing the effects of hazards.

Florida Administrative Code 27P-22.004 requires that the plan be updated every five years. These regulations are designed to inspire regular review of the LMS so that it truly does exist as a living document within each community.

In 1999, Manatee County adopted the first LMS, along with each of the cities, with updates in 2004, 2009, and 2014.

Furthermore, the Robert T. Stafford Act requires communities to have an approved LMS plan before they are eligible for federal mitigation grants.
