Good afternoon Mr. Byrd,

This is our final attempt to give you a chance to take care of this NSF check. We have been extremely patient but cannot let this go any longer. If you have not paid this by November 30th, we will have no choice but to turn this over to local Law Enforcement and the State Attorney's Office for criminal prosecution. You will then not only be liable for this NSF check and the NSF fee, you may be additionally liable in a civil action for triple the amount of the check along with court costs, reasonable attorney fees, and incurred bank fees.
