

RESOLUTION R-18-131

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY FLORIDA AUTHORIZING THE SUBMISSION AND ACCEPTANCE OF AN EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT FROM THE BUREAU OF JUSTICE ASSISTANCE, OFFICE OF JUSTICE PROGRAMS, U.S. DEPARTMENT OF JUSTICE; DESIGNATING THE PUBLIC SAFETY COORDINATING COUNCIL AS THE GRANT ADVISORY BOARD; AUTHORIZING THE CHAIRMAN, THE COUNTY ADMINISTRATOR OR THE DEPUTY COUNTY ADMINISTRATOR TO EXECUTE ALL APPROPRIATE DOCUMENTS RELATIVE TO GRANT SUBMISSION AND ACCEPTANCE; AND AUTHORIZING THE NEIGHBORHOOD SERVICES DEPARTMENT INTERIM DIRECTOR OR DESIGNEE TO EXECUTE ALL APPROPRIATE DOCUMENTS REQUIRED IN CONNECTION WITH THE GRANT ADMINISTRATIVE FUNCTIONS.

WHEREAS, Manatee County has determined that submission and acceptance of a Bureau of Justice Assistance, Office of Justice Programs, U.S. Department of Justice, Edward Byrne Memorial Justice Assistance Grant is in the best interests of the health and welfare of the citizens of Manatee County.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY AS FOLLOWS:

1. The submission and acceptance of an Edward Byrne Memorial Justice Assistance Grant FFY 2018 in the amount of \$111,590 is hereby authorized.
2. The Manatee County Public Safety Coordinating Council is designated as the Edward Byrne Memorial Justice Assistance Grant Advisory Board.
3. The Chairman or in his absence, the Vice Chairman of the Board of County Commissioners, or the County Administrator or the Deputy County Administrator are authorized to execute all necessary documents with regards to submission and acceptance of this grant.
4. The Neighborhood Services Department Director or her designee is authorized to execute all appropriate documents which may be required in connection with the administrative functions of this grant.
