RELEASE DEFECT SECURITY AGREEMENT
FOR FINAL LIFT OF ASPHALT
RELEASE SURETY BOND**

On December 4, 2014, the County Administrator on behalf of the Board of County Commissioners accepted a defect security agreement securing final lift of asphalt improvements which will be County maintained. On December 15, 2017, the Developer passed the defect inspection conducted by the Public Works Infrastructure Inspections Division. The developer has provided all required documents and completed the three (3) year period warranting all the public improvements secured by this Agreement and required by Manatee County to release: Therefore, per R-14-86, the following form of action is required:

- **Authorization to release** the following *Agreement in Conjunction with Surety Bond (Attachment "A") as Defect Security Warranting Required Improvements* securing final lift of asphalt improvements in the amount of \$3,103.38;
- **Authorization to release and return** the following Surety Bond, and any riders associated with this surety bond. Documents will be returned to Meritage Homes of Florida, Inc. located at 10150 Highland Manor Drive, Suite 120, Tampa, FL 33610;
 - **Surety Bond** No. 800013303 issued through Atlantic Specialty Insurance Company;
 - **Amount** of Performance Bond \$3,103.38.
