**Subject: Jurisdictional Review – Application File # V-19-505 Application to Vacate a Portion of Platted Right-of-Way in Pomello Park**

- This vacation application requests vacation of a portion of platted right-of-way in Pomello Park. The proposed area to be vacated is commonly referred to as 225<sup>th</sup> Street East. The proposed area to be vacated is approximately 0.686 acres or 29,862 square feet. The right-of-way was conveyed to the County by plat in Plat Book 6, Page 61, recorded in the Public Records of Manatee County.
- The Applicant requests vacation of the area since he wants to essentially combine the two (2) lots owned by G7/O7 Investments (that abut the right-of-way to the east and west) into one lot.
- Therefore, Property Acquisition is proceeding with the vacation process to vacate the platted right-of-way and is requesting your jurisdictional review comments for this Vacation. Attached is the legal and sketch (Exhibit “A”) for the area that is to be vacated for your review.

For matters of importance within the jurisdiction of the Manatee County Departments, a written assessment of the proposed vacation action is requested (a reply form is included for your convenience). 
