

**RESOLUTION NO. R-18-065**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONER OF MANATEE COUNTY, FLORIDA, AMENDING RESOLUTION R-18-038 OF THE PARKS AND NATURAL RESOURCES FEE SCHEDULE; PROVIDING FOR SEVERABILITY AND PROVIDING EFFECTIVE DATES.**

**WHEREAS**, §125.01(1)(f), Florida Statutes, authorizes the Board of County Commissioners of Manatee County, Florida, as the legislative and governing body of Manatee County, to provide parks, preserves, playgrounds, recreation areas, and other recreation and cultural facilities and programs; and

**WHEREAS**, parks and natural resources services are funded in part by user fees generated to cover all or a portion of the costs of such services so as to minimize the burden on the County's general revenue;

**WHEREAS**, Manatee County's parks and preserves are open to the public and used for the operation of planned special events organized and supervised by the Parks & Natural Resources Department; and

**WHEREAS**, Manatee County Code §2-24-12 provides that the Board of County Commissioners may, upon recommendation of the Parks and Natural Resources Department Director, adopt, modify or rescind fees or fee ranges for access to various facilities or services offered by the County; and

**WHEREAS**, the County Commission has previously adopted various fees which have been made a part of the Parks and Natural Resources Master Fee Schedule, and

**WHEREAS**, the changes now recommended for adoption are based upon clarification of Personal Training fees, and adding and increasing various fees throughout the Master Fee Schedule.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, THAT:**

1. The fee changes in Resolution R-18-065 are hereby amended, providing for the following changes to the Master Fee Schedule:
  - a. Add Mosiac NEST Rental Parameters & Procedures and Management Procedures to Policies section. (p.8-11)
  - b. Add Silver Sneakers and Optum Fitness insurance based programs to Recreation Membership section. (p.17)
  - c. Add Disabled Veterans 20% Discounted Recreation Membership fee. (p.17)
  - d. Clarify Personal Training and Personal Trainer fees. (p.18-19)
  - e. Remove Room Rental Fee - Small or Large Multi-Purpose Room (instructor use only). (p.19)
  - f. Separate "Outside Open Space" fee from Recreation Center, add to new Instructor Rentals category for select parks and preserves, and increase fee. (p.19-20)
  - g. Add Optum Fitness Tennis Membership fee. (p.21)
  - h. Add Mosaic NEST rental fees. (p.32)
  - i. Increase Kayak/Canoe Temporary Storage Rental fee. (p.31)
2. Fee changes a. – h. shall take effect as of May 8, 2018.
3. Fee change i. shall take effect as of October 1, 2018.

**BE IT FURTHER RESOLVED** that the provisions of this resolution are severable such that the invalidity of any one provision shall not operate to invalidate any other provision.
