

AMENDMENT NO. 1 TO AGREEMENT NO. 16-2117GD FOR MASTER PRODUCTS AND SERVICES AGREEMENT

This Amendment No. 1 to Agreement No. 16-2117GD (hereinafter Amendment) is made as of this 13th day of October, 2020 (hereinafter Effective Date) between Manatee County, a political subdivision of the State of Florida, with its principal place of business located at 1112 Manatee Avenue West, Bradenton, FL 34205 (hereinafter County) and Intergraph Corporation DBA Hexagon Safety & Infrastructure, a Delaware corporation (hereinafter Hexagon).

WHEREAS, on November 3, 2017, the County entered into an Agreement with Hexagon for master product and services (Agreement); and

WHEREAS, the County has determined a need to extend the Agreement and incorporate an aggregate Agreement not-to-exceed amount; and

WHEREAS, Hexagon agrees to continue to provide the products and services to the County in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants contained herein and for other good and valuable considerations, the receipt and sufficiency of which are hereby mutually acknowledged, the parties agree as follows:

1. Recitals

The above recitals are true and correct and are incorporated herein by reference.

2. Article 6, Agreement Term is hereby modified as follows:

The Term of this Master Agreement shall begin on the Effective Date (November 3, 2017) and remain in effect until November 2, 2021 or until the Master Agreement is earlier terminated pursuant to the terms set forth herein or by mutual agreement of the Parties. An Order that is executed prior to the expiration of the term of this Master Agreement shall be governed by this Master Agreement even if the Master Agreement Term expires during the performance of the Order.

3. Supplemental Terms and Conditions

The terms and conditions of the Agreement are hereby modified or supplemented as follows:

- a. *Dollar Amount.* This Agreement shall be in full force and effect on the Effective Date for an aggregate Agreement total not-to-exceed amount of One Million Five Hundred Thousand Dollars (\$1,500,000.00).

4. The Agreement

The Agreement and Amendment No. 1 represent the entire understanding between the Parties.

5. Terms and Conditions

Except as otherwise stated herein, the terms and conditions of the Initial Agreement shall constitute the terms and conditions of this Agreement. A true and correct copy of the Initial Agreement is hereby incorporated by this reference.
