AMENDMENT NO. 1 TO AGREEMENT NO. 17-1253MS FOR PROFESSIONAL ENVIRONMENTAL AND MARINE ENGINEERING SERVICES

This Amendment No. 1 to Agreement No. 17-1253MS (hereinafter Amendment) is made as of this 7th day of October, 2020 (hereinafter Effective Date) between Manatee County, a political subdivision of the State of Florida, with its principal place of business located at 1112 Manatee Avenue West, Bradenton, FL 34205 (hereinafter County) and Coastal Engineering Consultants, Inc., a Florida corporation, whose address is 3106 South Horseshoe Drive, Naples, Florida 34104, (hereinafter Consultant).

WHEREAS, on October 17, 2020 the County entered into an Agreement with Consultant for Professional Environmental and Marine Engineering Services (Agreement); and

WHEREAS, the County has determined a need for services beyond the initial three (3) year period ending October 16, 2020; and

WHEREAS, Consultant agrees to continue to provide the Professional Environmental and Marine Engineering Services to the County in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants contained herein and for other good and valuable considerations, the receipt and sufficiency of which are hereby mutually acknowledged, the parties agree as follows:

2. Amendment

This Amendment No. 1 renews the Agreement for the period of October 17, 2020 through October 16, 2021. There is one (1) one-year renewal option remaining.
