

AMENDMENT NO. 5 TO PRESCRIPTION DRUG BENEFIT ADMINISTRATION AGREEMENT

This Amendment No. 5 to Prescription Drug Benefit Administration Agreement (hereinafter Amendment) is made as of this 29th day of September, 2020 (hereinafter Effective Date) between Manatee County, a political subdivision of the State of Florida, with its principal place of business located at 1112 Manatee Avenue West, Bradenton, FL 34205 (hereinafter County) and OptumRx, Inc., a California corporation, whose address is 1600 McConnor Parkway, Schaumburg, IL 60173, (hereinafter Administrator).

WHEREAS, on January 1, 2017, the County entered into an Agreement with Administrator for prescription drug benefit administration (Agreement); and

WHEREAS, on December 28, 2018, the parties hereto entered into Amendment No. 1 which renewed the Agreement beginning January 1, 2019 and ending December 31, 2022 and incorporated Section 3.9, Market Check into the Agreement; and

WHEREAS, on August 13, 2019, the parties hereto entered into Amendment No. 2 which incorporated an enhanced savings program addendum in the Agreement; and

WHEREAS, on October 22, 2019, the parties hereto entered into Amendment No. 3 to increase the aggregate Agreement not-to-exceed total and amend the Agreement terms and conditions; and

WHEREAS, on November 1, 2019, the parties hereto entered into Amendment No. 4 to remove Exhibit F, Enhanced Savings Program; and

WHEREAS, the County has determined the need to increase the aggregate not-to-exceed amount; and

WHEREAS, Administrator agrees to continue to provide the prescription drug benefit administration to the County in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants contained herein and for other good and valuable considerations, the receipt and sufficiency of which are hereby mutually acknowledged, the parties agree as follows:

1. Recitals

The above recitals are true and correct and are incorporated herein by reference.

2. This Amendment No. 5 increases the Agreement aggregate total not-to-exceed amount in the amount of \$355,000.00 for a revised Agreement aggregate total not-to-exceed amount of \$1,000,000.00.

3. The Agreement

The Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4 and Amendment No. 5 represent the entire understanding between the Parties.

4. Terms and Conditions

Except as otherwise stated herein, the terms and conditions of the Initial Agreement shall constitute the terms and conditions of this Agreement. A true and correct copy of the Initial Agreement is hereby incorporated by this reference.
