

AMENDMENT NO. 5 TO AGREEMENT NO. 16-0793FL FOR ADMINISTRATIVE SERVICES FOR ULTRA LOW FLOW TOILET REBATE PROGRAM

This Amendment No. 5 to Agreement No. 16-0793FL (hereinafter Amendment) is made as of this 1st day of October, 2020 (hereinafter Effective Date) between Manatee County, a political subdivision of the State of Florida, with its principal place of business located at 1112 Manatee Avenue West, Bradenton, FL 34205 (hereinafter County) and Demetri's Solutions, LLC, a Florida limited liability company, whose address is P.O. Box 6905, Springhill, FL 34611, (hereinafter Contractor).

WHEREAS, on April 1, 2016, the County entered into Agreement No. 16-0793FL with Contractor for Administrative Services for Ultra Low Flow Toilet Rebate Program for a not-to-exceed total of \$679,500 (Agreement); and

WHEREAS, on February 26, 2019, Amendment No. 1 renewed the Agreement for the period of April 1, 2019 through September 30, 2019 and increased the semi-annual not-to-exceed amount of \$75,500 for a revised not-to-exceed total of \$755,000; and

WHEREAS, on April 23, 2019, Amendment No. 2 corrected a scribing error to the not-to-exceed amount; and

WHEREAS, on October 1, 2019, Amendment No. 3 renewed the Agreement for the period of October 1, 2019 through March 31, 2020 with a semi-annual not-to-exceed amount of \$75,500 for a revised not-to-exceed total of \$830,500; and

WHEREAS, on April 1, 2020, Amendment No. 4 renewed the Agreement for the period of April 1, 2020 through September 30, 2020 with one six-month renewal remaining; and

WHEREAS, the County has determined a need to extend the Agreement and increase the semi-annual not-to-exceed amount; and

WHEREAS, Contractor agrees to continue to provide the administrative services for the ultra low flow toilet rebate program to the County in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants contained herein and for other good and valuable considerations, the receipt and sufficiency of which are hereby mutually acknowledged, the parties agree as follows:

1. Recitals

The above recitals are true and correct and are incorporated herein by reference.

2. This Amendment No. 5 extends the Agreement from October 1, 2020 through March 31, 2021 in the semi-annual not-to-exceed amount of \$98,500.00 for a revised aggregate not-to-exceed amount of \$929,000.00.

3. The Agreement

The Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4 and Amendment No.5 represent the entire understanding between the Parties.

4. Terms and Conditions

Except as otherwise stated herein, the terms and conditions of the Initial Agreement shall constitute the terms and conditions of this Agreement. A true and correct copy of the Initial Agreement is hereby incorporated by this reference.
