

AMENDMENT NO. 8 TO PHARMACEUTICAL CONSULTING SERVICES AGREEMENT

This Amendment No. 8 to the Agreement (hereinafter Amendment) is made as of this 29th day of September, 2020 (hereinafter Effective Date) between Manatee County, a political subdivision of the State of Florida, with its principal place of business located at 1112 Manatee Avenue West, Bradenton, FL 34205 (hereinafter County) and Pharmacy Healthcare Solutions, Inc., a Pennsylvania corporation, whose address is 968 Perry Highway, Pittsburgh, PA 15237, (hereinafter Consultant).

WHEREAS, on December 12, 2011, the County entered into an Agreement with Pharmacy Healthcare Solutions beginning on October 1, 2011 and ending September 12, 2013 for pharmaceutical consulting services (Initial Agreement); and

WHEREAS, on January 8, 2014, the parties hereto entered into Amendment No. 1 to extend the Agreement through September 30, 2014 for a not-to-exceed amount of \$78,000.00; and

WHEREAS, on October 1, 2014, the parties hereto entered into Amendment No. 2 to extend the Agreement through September 30, 2015 for a not-to-exceed amount of \$78,000.00; and

WHEREAS, on October 5, 2015, the parties hereto entered into Amendment No. 3 to extend the Agreement through September 30, 2016 for a not-to-exceed amount of \$98,000.00; and

WHEREAS, on October 6, 2016, the parties hereto entered into Amendment No. 4 to extend the Agreement through September 30, 2017 for a not-to-exceed amount of \$98,000.00; and

WHEREAS, on October 19, 2017, the parties hereto entered into Amendment No. 5 to extend the Agreement through September 30, 2018 for a not-to-exceed amount of \$98,000.00; and

WHEREAS, on October 24, 2018, the parties hereto entered into Amendment No. 6 to extend the Agreement through September 30, 2019 for a not-to-exceed amount of \$76,400.00; and

WHEREAS, on October 1, 2019, the parties hereto entered into Amendment No. 7 to extend the Agreement through September 30, 2020 for a not-to-exceed amount of \$98,000.00; and

WHEREAS, the County has determined a need to extend the Agreement and revise the management consulting fee; and

WHEREAS, Consultant agrees to continue to provide the pharmaceutical consulting services to the County in accordance with the terms and conditions of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants contained herein and for other good and valuable considerations, the receipt and sufficiency of which are hereby mutually acknowledged, the parties agree as follows:

1. Recitals

The above recitals are true and correct and are incorporated herein by reference.

2. This Amendment No. 8 extends the Agreement for the period of October 1, 2020 through September 30, 2021 for a not-to-exceed amount of \$98,000.00.

3. Scope of Service, E. Professional Fees and Expenses for Pharmaceutical Consulting Services is hereby modified as follows:

Management Consulting Fee	\$325.00

4. The Agreement

The Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, Amendment No. 5, Amendment No. 6, Amendment No. 7 and Amendment No. 8 represent the entire understanding between the Parties.

5. Terms and Conditions

Except as otherwise stated herein, the terms and conditions of the Initial Agreement shall constitute the terms and conditions of this Agreement. A true and correct copy of the Initial Agreement is hereby incorporated by this reference.
