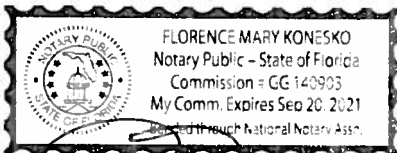

NOTICE IS HEREBY GIVEN, pursuant to Section 125.66 of Florida Statutes, that the Board of County Commissioners of Manatee County, Florida, will conduct a public hearing in the Chambers of the Board of Manatee County Administrative Complex, 1112 Manatee Avenue West, first floor, Bradenton, Florida, on February 13, 2018, at 9:00 a.m., or soon thereafter, to consider, act upon, enact or reject the following Resolution:

RESOLUTION NO. R-18-021

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, REGARDING PUBLIC FINANCE, AMENDING RESOLUTION NO. R-17-105 TO CHANGE THE TRANSPORTATION INFRASTRUCTURE SALES TAX PROJECT AND EQUIPMENT LIST TO REMOVE \$590,000 AND TO ADD \$785,000; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.
