ACCEPT SURETY BOND VERIFICATION CERTIFICATE
FOR DEFECT SECURITY AGREEMENT**

On January 27, 2015, the Board of County Commissioners accepted a defect security agreement which must remain in place for three (3) years from County acceptance of that agreement. This project has failed the defect inspection and requires more time to complete the issues noted on the inspection report. The Surety Bond secured by Arch Insurance extends the expiration date to give the Developer the time necessary to make the required repairs. Therefore, per R-14-86, the following form of action is required:



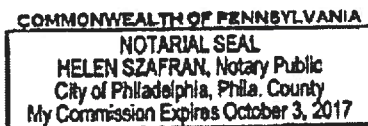
