ORDINANCE NO. 15-07

AN ORDINANCE OF MANATEE COUNTY, FLORIDA, AMENDING SECTION 2-22-7 OF THE MANATEE COUNTY CODE INSTITUTING AND CREATING AN ADDITIONAL SPEED LIMIT ZONE TO INCLUDE MULHOLLAND ROAD; PROVIDING FOR SUBSTITUTION OF "PUBLIC WORKS DEPARTMENT" and 'PUBLIC WORKS DIRECTOR" FOR "TRANSPORTATION DEPARTMENT" and "TRANSPORTATION DIRECTOR" IN CHAPTER 2-22 OF THE MANATEE COUNTY CODE; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Florida Statute Section 316.189(2), authorizes the Board of County Commissioners of Manatee County to set maximum and minimum speed limits in zones after an investigation and determination that such limits are reasonable and in conformity with criteria promulgated by the Florida Department of Transportation.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1. Manatee County Code Section 2-22-7(a)(1) is amended to add the following new speed zone and limit:

Mulholland Road 35 mph (from Fort Hamer Road to the dead end west of Twin Rivers Trail)

- SECTION 2. The Codifier shall convert references to "Transportation Department", "Transportation Director", "transportation department", and "transportation director" found in any part of Chapter 2-22 into references to "Public Works Department", "Public Works Director", "public works department", and "public works director".
- SECTION 3. If any section, subsection, sentence, clause, provision or word of this Ordinance shall be held invalid, same shall be severable and the remainder of this Ordinance shall not be affected by such invalidity. The Manatee County Board of County Commissioners expressly indicates that it desires any remainder of the Ordinance to withstand any severed provision, as it would have adopted the Ordinance and its regulatory scheme even absent the invalid part.
- SECTION 4: The Codifier shall codify the substantive amendments to the Manatee County Code contained in Sections 1 and 2 of this Ordinance as provided for therein, and shall not codify any other sections not designed for codification.

SECTION 5: This Ordinance shall take effect immediately upon filing with the Department of State in Tallahassee, Florida.
