A RESOLUTION OF THE MANATEE COUNTY BOARD OF COMMISSIONERS AUTHORIZING THE SIGNING AND SUBMISSION OF AN ANNUAL GRANT APPLICATION AND SUPPORTING DOCUMENTS AND ASSURANCES TO THE FLORIDA DEPARTMENT OF TRANSPORTATION, THE ACCEPTANCE OF A **FROM GRANT AWARD** THE FLORIDA **DEPARTMENT** TRANSPORTATION AND THE PURCHASE OF VEHICLES AND/OR AND/OR **EXPENDITURE** OF CAPITAL/OPERATING **EOUIPMENT** ASSISTANCE GRANT FUNDS PURSUANT TO A GRANT AWARD.

WHEREAS, the Manatee County Board of County Commissioners/Manatee County Area Transit (MCAT) has the authority to apply for and accept grants and make purchases and/or expend funds pursuant to grant awards made by the Florida Department of Transportation as authorized by Chapter 341, Florida Statutes and/or by the Federal Transit Administration (FTA) Act of 1964, as amended; and

WHEREAS, the Florida Department of Transportation (FDOT) has the authority to administer FTA Section 5310 Program funding as the Designated Recipient for the Sarasota/Bradenton urbanized area (UZA).

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA:

- 1. This resolution applies to Federal Program(s) under U.S.C. Section(s) 5310 Formula Grants for the Enhanced Mobility of Seniors and Individuals with Disabilities.
- 2. The Chairperson or in their absence, the Vice Chairperson, is hereby authorized to sign the application and accept the grant award, and sign a Joint Participation Agreement (JPA) for both capital and operating assistance funding; and upon JPA execution, staff is authorized to proceed with purchase of vehicles/equipment and/or expenditure of capital/operating grant funds pursuant to a grant award, and approval for FY 2017/18 Section 5310 funding, unless specifically rescinded.
- 3. The BOARD authorizes the <u>Transit Division Manager</u> to sign any and all assurances, reimbursement invoices, warranties, certifications and other documents which may be required in connection with the application or subsequent agreements.
