
TO ALL WHOM IT MAY CONCERN


**ORDER ADMITTING WILL TO PROBATE

8. Domiciliary or principal proceedings are not known to be pending in another state or country.


9. The decedent's last will dated February 23, 2017, is in the possession of the court or accompanies this petition.
